MINUTES

The regular monthly meeting of PERB was held on July 27, 2017, at 11:15 a.m. at PERB headquarters. Board Member Douglas Warshof, presiding. Board Member Barbara Somson and Board Member Mary Anne Gibbons were present. Board Member Douglas Warshof welcomed new Board Member Mary Anne Gibbons.

Executive Director Martin reported the following:

- Executive Director Martin welcomed new Board Member Mary Anne Gibbons.

C. Ravshawn Douglas vs DCHA

PERB Case No. 15-U-32

Rayshawn Douglas filed this Unfair Labor Practice Complainant alleging that the District of Columbia Housing Authority ("DCHA") discriminated against her in violation of ("CMPA") because she engaged in protected union activity. The matter was sent to a hearing and the hearing examiner's report and recommendation is now before the Board.

PERB Case No. 17-I-03
